increased amount of record checks, taking statements, administrative, etc.

- Would like to a new building since the current is old, very small, and have grown out of it. Not very usable for what is needed now. Approached the Town of Stettler to help.
- In 2026, the building will be renovated with the federal government, and a jail cell will become a room for interrogation because the current situation is not safe for staff in the building.
- Encourage for people to call the detachment for non-emergent issues. The Alberta RCMP app/online crime reporting is not looked after local.
