



## COVID-19 HALL USER GUIDELINES

The Summer Village of White Sands is dedicated to providing safe and clean rental space for family and social events. In order to ensure this, users are required to adhere to certain guidelines and conditions. As this facility is not supervised by the Municipality any and all users, activities or rentals must adhere to the provincial Covid-19 Guideline requirements and as municipal operator of the hall the municipality could be audited for compliance of the regulations.

### **PROVINCIAL COVID-19 GUIDELINES:**

#### **Mandatory restriction - Effective Sept. 16 and 20**

- Indoor entertainment, event and recreation facilities (Sept 20)
- Indoor facilities that do not implement the Restrictions Exemption Program must follow these restrictions:
  - Capacity limited to 1/3 fire code occupancy.(~10)
  - Attendees must be with household members only, or 2 close contacts if they live alone.

#### **Mandatory restriction - Effective Sept. 16 and 20**

##### **Adult (18-plus) sport, fitness and performance activities (Sept 20)**

The following restrictions apply unless the facility or program implements the **Restrictions Exemption Program**:

- Indoor group classes and activities are not permitted.
- Indoor competitions are paused except where vaccine exemptions have been granted.
- Indoor one-on-one training and solo activities are allowed with 3 metre physical distancing.
- Outdoor activities can continue with no restrictions.

#### **Mandatory restriction - Updated October 5**

##### **Indoor social gatherings**

- Vaccinated: Indoor private social gatherings are limited to 2 households (yours plus one other) up to a maximum of 10 vaccine-eligible, vaccinated people and no restrictions on children under 12.
- Unvaccinated: Indoor social gatherings are not permitted for vaccine-eligible people who are unvaccinated.
- This restriction does not apply to mutual support groups, or to workers who need to access your home to provide caregiving support or home repairs and maintenance.

#### **Mandatory restriction – Effective Sept. 16**

- Masking and 2 metres physical distancing are mandatory in all indoor public spaces, workplaces, and places of worship.
- Employees must mask in all indoor work settings, except while alone in work stations.
- The Restrictions Exemption Program does not apply to masking. Masks are still required in places that implement the program.

### **RENTAL ADVISORY:**

1. Renter/User will be responsible for monitoring attendance so as not to exceed the allowed max occupancy under provincial Covid 19 Restrictions.
2. Renter/User is responsible for maintaining an attendee roster and contact information, if required for contact tracing.
3. Renter/User is responsible for knowing and adhering to all appropriate provincial Covid-19 restrictions and regulations for their event and communicating to attendees.
4. Renter/User is responsible for communication with attendees stating that those exhibiting symptoms or feeling ill will not attend the event.
5. If any safety protocols are not being adhered to the Renter/User assumes all liability, risk and accountability of their event.
6. The congregation of vulnerable populations is not recommended and could pose a serious health risk to those individuals. It is the responsibility of the Renter/User to communicate this with any vulnerable individuals that are planning to attend their event.
7. If any individuals become ill with the COVID-19 virus after attending an event at the hall, the renter/user understands that the Summer Village is not liable
